"ENTREKIN, THOMAS

b. 25 October 1759, Pennsylvania d. 19 June 1839 m. Mary _' _ August 1791, Laurens County, South Carolina

While residing in Ninety Six District, South Carolina, Thomas Entrekin enlisted under Capt. Robert Gillam. In September 1777 he enlisted under Capt. William Mulwee. He enlisted during May 1778 under Capt. Benjamin Kilgore. In October 1778 he enlisted under Capt. Mulwee and in 1779 he was under Capt. Charles Saxon. In 1780 he served under Capt. William Mulwee and Col. Robert McCreary. On 23 October 1780, he enlisted under Col. Joseph Hayes and was in the battles at Blackstock's Plantation, Hammond's Old Store, and Cowpens. While visiting an uncle after the battle at Guilford Courthouse (which he was in), he joined a unit under Count Malmedy. He eventually returned to Hayes's regiment In South Carolina. At sometime, he was a sergeant. He was allowed pension on his application executed 30 September 1834 while residing in Laurens County, South Carolina. His widow was allowed pension on her application executed 2I January 1845 while residing in Coweta County, Georgia, and aged seventy-six years. A daughter, Kezai Vickery, was born 6 June 1792 and twin girls (their names not given) were born prior to May 1794. FPA W7112; AA 1893B; AA 2231; W447; CS. "

"WHITE, JOSEPH (JAMES), Capt.

Joseph White served as a captain in the battles at Kings Mountain (where he was wounded) and Cowpens. One James White was a captain and later lieutenant-colonel In the militia from Guilford County, North Carolina. Schenck, p. 221; White, p. 233; North Carolina Roster, pp. 42, 62, 183, 235, 460, 581, 589."

Note: Garbled. James and Joseph were two different people. This Joseph White is the brother of Thomas White (below) and also the Son of Thomas White SR () who died in Knox Co, TN in 1793. I believe James white was one of Johns River Whites, possibly the son of James Taylor White and Elizabrth Powe. TAH

WHITE, THOMAS, Lt.

b. c. 1754, Scot-Irish Parentage d. 1824, Bond County, Illinois

Thomas White, with his younger brothers, Isaac and James, migrated to Lincoln County, North Carolina, about 1779. He was a lieutenant under his brother, Capt. James (Joseph?) White, In the battles at Kings Mountain and Cowpens. Draper, p. 478; (Martin, Josiah, W1047).

"Indians and Pioneers in Pre-Burke County Territory / 43

Added together, the English and Welsh were probably the most numerous of the early Burke settlers. They were largely derived from the Tidewater population of eastern Virginia, and first penetrated into the Piedmont region of that State. Later they drifted down into the North Carolina Piedmont and then moved westward into the Burke County area. An occasional English or Welsh settler came from Maryland or from the coastal region of North or South Carolina. A few families of Irish, French Protestant (Huguenot), Swiss, and Dutch extraction were among the early settlers in the County.

Common English names among the early settlers in Present Burke were Anderson, Avery, Bailey, Berry, Bradshaw, Branch, Brittain, Byrd (Bird), Carswell (Criswell), Causby (Cosby), Chapman, Clark (e), Cooper, Denton, Fox, Franklin, Gibbs, Hall, Hensley, Henson, Hicks, Johnson, Lane, Oxford, Parks, Penley (Pendley), Perkins, Piercy, Pritchard, Roper, Simpson, Stillwell, Taylor, Webb, and White. Common Welsh names were Davis, Edwards, Harris, Jones, Morgan, Phillips and Williams."

"General Characteristics of the Burke Pioneer

Those who resided in the territory beyond the Catawba-the area that was in 1777 to become Old Burke-were citizens of the frontier. They possessed the traits that major historians have so frequently attributed to this group-courage, resourcefulness, adaptability, a certain restlessness that has fathered the word "shiftlessness," and a craving for complete independence. The loneliness of the frontier molded them into individualists. In the main they were rough, uneducated, and they did not eschew violence; but they were filled with a spirit of adventure and a burning desire for economic betterment. Land, they felt, was the key to their future contentment. A good all-weather spring, a stream, a little streak of bottom land that one could clear and cultivate, and sufficient woodland to supply fuel, shelter and game, seemed to satisfy current needs. No creek, fork or branch was too small for them to settle on. ---- In a similar manner **Joseph White** entered 640 acres "lying on **White's fork** of Silver Creek," including the parcel on which he was living. The tributaries of Silver Creek, Hunting Creek, Upper Creek, and Irish Creek were thickly populated with settlers."
